# **Issue for City Departments:**

Officer Hamblin introduced himself to the group. Officer Yarema updated the group regarding the CPTED (Crime Prevention through Environmental Design) on Gifford Street. Working with Codes, DPW and the Police Department, improvements have been made to the street. The Visioning Voices speaker series held on November 15<sup>th</sup> highlighted CPTED on the Near Westside. A video of the workshop will be made available in the near future. A resident stated that there has been a continual problem regarding illegal dumping of TV's and trash on a vacant house on Wilkinson St. Officer Yarema suggested taking any information on the person dumping and report to the Police. It was recommended that people make a log of dumpings so that TNT can compile data to present to the proper departments at future meetings.

# TNT City-wide Board Delegate Update

Rick Destito informed the group regarding the Facilitator Training on November 28<sup>th</sup>. Rick stated that a few items on the Strategic Plan's final report have been accomplished. Frank Cetera, TNT Treasurer, explained that TNT is one 501c3 and all sector grant applications must submit a memo to the TNT board for approval.

**Katelyn Wright,** *Executive Director for the Landbank*: Ms. Wright presented the group with large maps indicating the parcels that have been sold, demo candidates, houses yet to be acquired. The areas on the map that were colored blue indicate properties sold to HHQ.

**Kerry Quaglia,** *Executive Director for Home Headquarters*: Mr. Quaglia stated that state funding has been secured to develop 7 rentals and 4 owner occupied houses.

Discussion continued around the process of obtaining a Landbank property and the ways in which individuals can secure mortgages and loans to remodel the structures. If anyone would like to propose ideas for vacant Landbank properties, they will be interested in working with a group through TNT.

Frank Cetera and Tina Zagyva, *TNT Coordinator*, discussed the Special Project Timeline, proposal forms and overview of the Guidelines with the group in attendance.
