Issues for City Department Officials

- 1) A resident noted tires being dumped on Leon by Dr. King, 7-8am last week. More tires are there. Captain DelFavero will check.
- 2) Kirk and Landon car thefts. Keep Valuables out of sight and make sure doors are locked.
- 3) Warner Ave kids/preteens going into cars. Might have been in November, police never came. Capt. DelFavero stated the calls need to be responded to, response may have been at 2am. You can file a report online.

- 5) Shooting on Elmwood Ave. Captain Delfavero will check and update the group

- 1) Module 1 completed: New District & Uses

- 3) Module 3: Administration & Procedure Late Spring/Summer Once approved by Council it will become local law by late summer 2017.

Residents inquired about residential districts, review of the map before/prior to vote. Hard copies needed as without them it would disenfranchise half of the people in Southside.

- Q. How will owners who own multiple parcels be affected?
- A. Councilor Bey further explained the expanded Planned Districts. Rezoning is best bang for buck
- Q. Will owners know of these new zoning districts?
- A. Not unless they ask
- Q. House demolished, vacant lots then deemed unbuildable due to size
- A. Not necessarily true, If its 40,000 sq ft I can be built but must meet yard and density requirements There will be a section of the new ordinance (section C) that will explain this

Q. Will historical houses be protected

A. Yes

Q. Will this ordinance protect us from having a 3rd family dollar with its back to us?

A. The new ordinance will speak to design standards. It was the lack of design standards that allowed that to happen. Design standards will be local law for our community; it will not be a request. Councilor Bey stated that the New Dollar Store has doors on the street facing South Salina (not open yet).

Councilor Bey stated that the Government needs as many community ambassadors as possible, this TNT meeting is ideal to help the city get the word out.
