## Issues for District Representatives/Elected Officials/City Departments: none present

<u>Special Projects</u>: Each TNT sector has a total of \$5,000 for community building projects; 4 projects were proposed and voted upon by the members in attendance.

- 1) Meadowbrook Neighborhood Association withdrew its request for \$700; they received a donation.
- 2) Westcott Community Center requested \$921 for a trash receptacle.
- 3) The Thornden Park Association requested \$795 for signage replacement.
- 4) Barry Park Association requested \$4,255 for a pet friendly water fountain.

Tom Quinn motioned to approve the Westcott Community project and the Thornden Park Association project in full, and the Barry Park Association in the amount of \$3,284. Harry Lewis 2<sup>nd</sup>, all were in favor.

<u>TNT City-wide Board Update:</u> Tina Zagyva informed the group that beginning in April, the CNY Community Foundation will be providing funding for food at the TNT meetings.
