June 26th Meeting Minutes: Judy Scheuer motioned to approve the minutes as written, Syeisha Byrd 2nd, all were in favor.

Issues for Elected Officials/City Departments: Captain Fougner provided a crime analysis for the Northside. Questions were taken from the floor. Issues were raised over the lack of police coverage for the area in relation to other sections of the City.

Building Equity in the Construction Trades & Preparing for the DEIS hearing: Andrew Croom with CNY Legal Services and Aggie Lane, with the Urban Jobs Task Force, provided statistics regarding workers hired for the construction trade; worksites were primarily white, predominantly male and most came from outside of Syracuse. There were a few minor changes made to the guidelines; all capital improvement projects to be installed on City property must obtain proper permission from City departments before being approved and proposals from organizations that have participated with TNT frequently will receive priority.
