Issue for City Departments/Elected Officials/District Representatives: Captain Sobiech presented a crime report for the near westside. Mary Margaret, with Neighborhood & Business Development, stated that NBD currently has a lead grant program that residents can apply to; information can be found on the City website.

Building Equity in the Construction Trades & Preparing for the DEIS hearing: Aggie Lane, with the Urban Jobs Task Force, provided statistics regarding workers hired for the construction trade; worksites were primarily white, predominantly male and most came from outside of Syracuse.
