### Land Bank:

Katelyn Wright, Executive Director of the Syracuse Land Bank, discussed plans to develop numerous Land Bank properties on the Southside to build 66 units - 20 (1) bedroom; 31 (3) bedroom; 15 (4) bedroom – 7 ADA fully accessible and 3 hearing vision units. Michelle Sczpanski, Neighborhood Business Development Director of Housing and Planning, explained the Resurgent Neighborhood Initiative and its relationship to the proposed project. Diana Jakimoski, Housing Visions' Director of Development, provided a PowerPoint presentation providing an overview of Housing Visions as well as the proposed development project. There will be property management; criminal, credit, sex offender, income and asset verification and landlord references will be administered as well as active, ongoing management; annual income/asset certification, unit inspection, resident orientation, etc. Current projected timeline completion by 2024.
