He reported that there were a significant number of arrests attributed to burglaries. The numbers continue to be problematic for the community. Numerous burglaries identified were associated with identified groups of individuals. Although the numbers remain high, they have plateaued. If you see something, say something. Captain Bowering, encouraged the community to report any suspicious activities. Neighbors have been great with sharing videos and other information to help offset some of the activities. Captain Bowering will submit copies of the report to the committee for distribution.
