Joe Cecile, Chief of Police

Chief Cecile provided a brief overview of his history with the Police force. Nuisance properties were discussed, specifically in regards to Skyline and corner stores. The Police will be utilizing and app with a variety of service providers to address different situations that may not always require Police intervention. Police quadrants were discussed; the Northside has a large section and the department is currently reviewing the sizes of each quadrant. Firework season is coming up, there are specific proactive firework details ready to go during the busy season such as July. There is also an ATV/dirt bike detail that is separate from regular patrolling. The council recently passed an ordinance that increases the fines in order to retrieve the confiscated ATV/dirt bikes. Captain Milano provided a brief crime report. Questions were taken from the floor.

Assemblyman Bill Magnarelli

Assemblyman Magnarelli addressed the issues on bail reform and raise the age. There have been changes to bail reform since the last time Assemblyman Magnarelli attended the Northside TNT meeting. Burglaries, commercial burglaries, second time offenders, loaded firearm, illegal firearms possession, criminal possession of a firearm, etc. are now bail eligible. Money was secured to provide funding to District Attorney offices to up their staff and technology so that communication is clearer between different townships and judicial systems. More C.O.P.S. cameras will be installed on the Northside in the near future. Questions were taken from the floor.
